Further to your Freedom of Information Request, please find the Trust's response below:

On the 14th May we launched Diabetes UK's report and campaign addressing the links between diabetes and emotional and mental health.

We know there is encouraging work being done in this area, and we want to know more about where these services are being provided, and how many people living with diabetes are accessing them.

To do this, we have enclosed a Freedom of Information request with questions on the services you provide and those accessed by people living with diabetes in your area.

This request will help us better understand the good work which is happening and promote good practice examples.

Kindly note as follows:

Humber Teaching NHS Foundation Trust ('the Trust') have specialist diabetes staff within its Scarborough and Ryedale region who are part of the MDT however, there are no mental health professionals as part of that team and patients are referred on to the local IAPT service if required. Whilst we have included this team within our response to question 1, we have not provided information relating to questions 2 and 3.

The Trust also has a team of specialist practitioner's within its Mental Health Liaison Service who have contact with the Diabetes Service on one day per week, not including annual leave. The response to questions 2 and 3 is therefore in respect of this team.
