Thank you very much for the response to our FOI request - this is really helpful and just what we are looking for! We really appreciate your assistance on this request.

I just have a clarification question - would you mind confirming that the figures for the individuals **not** coded as health visitors (response to Q3) represent individuals that hold caseloads? This was asked in the original request, but has caused confusion with other Trusts so I just want to check this with you!

Humber Teaching NHS Foundation Trust ('the Trust') can confirm that these do not represent individuals holding caseloads. These are Band 6 school nurses working in the 0-19 teams who help







with other areas of support in the team such as Duty. The Trust would not Count these individuals when adding up HV caseload sizes.

For the avoidance of any doubt, the Trust can confirm that all of the Band 6, 7, and 8a figures referred to in the left hand columns are representative of individuals with caseloads.
