Further to your Freedom of Information Request, please find the Trust's response below:

Under the Freedom of Information Act, can you provide me with the following information: Kindly note, at Humber Teaching NHS Foundation Trust ("the Trust"), we did not have a dedicated Eating Disorder Service in 2010, but the Trust did follow an ED pathway at this time. Patient figures for 2010 however cannot be extracted due to a change in system used by the Trust.

Currently, the CAMHS Eating Disorder Service covers Hull and East Riding. This has not always been the case.

Due to changes in national waiting times, during 2019 and 2020 the Trust aimed for urgent referrals to be seen for assessment and treatment within a week and routine referrals within 4 weeks.

1) Please can you provide me with a list of the number of children who have been treated for eating disorders within the following years 2010 and 2019 and 2020 (so far). To clarify my request, I require the following:

- By children, I mean those under the age of 18. Please can you break down my request into the following age categories:

- 0-2; 3-5 6-7; 8-9; 10; 11; 12; 13; 14; 15; 16; 17-18

I would like to make it clear that I am not asking for personal information, merely the number of patients who have been treated for eating disorders in each age bracket. To clarify further, by eating disorders, I mean anorexia, bulimia or similar problems.

I would ask that the figures be separately listed for the following time brackets 2010 and 2019 and 2020 (so far).

Please find below figures for 2019 and 2020 (to date). Please note, in order to adhere to best practice in maintaining confidentiality, the Trust does not publish numbers lower than 5 as this could lead to the identity being revealed. Exemption – Section 40(2) of the Freedom of Information Act is applied. To disclose the information requested would be in breach of the Data Protection Act (2018).
