



## Foundation Trust Membership Privacy Notice

Thank you for becoming a member of our Foundation Trust. This notice is to inform you about how the personal data collected in your membership application form will be used by the Trust.

Your information will be held securely and used in accordance with data protection legislation.

### Using your personal data: the legal basis and purpose

We collect your contact details for the purpose of communicating with you about things that are happening in the Trust. This also includes you receiving our membership magazine, inviting you to member's events or meetings and informing you about our Governor elections .

We only process this information when it is in the **legitimate interests** of the Trust (UK GDPR Article 6(1)(f)).

We also collect information to ensure that our membership is representative of the community we serve. This includes collecting special categories of information such as sexual orientation, religious beliefs, ethnicity and whether you consider you have a disability. Providing this information is optional.

The legal basis for this processing is **necessary to perform a public task** (UK GDPR Article 6(1)(e)) and also **necessary for reasons of substantial public interest** (UK GDPR Article 9(2)(g)).

We are required to maintain a public register of our members. You can opt out of this at any time by contacting the Membership Office on telephone number: 01482 389132 or email: [hnf-tr.members@nhs.uk](mailto:hnf-tr.members@nhs.uk).

The legal basis for this processing is **necessary to perform a public task** (UK GDPR Article 6(1)(e)).

### How long will we keep this information?
